The people of the village also support it. So let us reach an agreement and give 3 days to one division. I would also like to know your response in this regard.

Honorary Chairman Mr. H. A. H. Devendra Perera - Sri Lanka Podujana Peramuna

The premix project could not be done in recent days due to the non-availability of Koalas. So far those ingredients22Everything has been received. Members of Parliament also continued to talk about the non-development of broken roads in open water pipes. Accordingly, I advised to first repair all the broken roads during the laying of water pipes in Talpitibadda area. So far, according to the document we have, we have prepared those places in Talpitibadda area. Last week, the authority has given instructions to repair the broken roads during the laying of water pipes in the area. After that, after those roads are built, as the Piyasena MP said, I will give the opportunity to premix those roads after seeing which roads should be given priority in each division.

There was a delay in repairing the lights. In the past, the government had advised not to install and repair lights. So far we have got the necessary materials. By now, a large number of lights have been switched off. They are trying to bring it back to normal as soon as possible. After that, we will arrange to install new street lights in the areas requested by the MPs.

Honorable Chairman, I personally intervened to deliver garbage to the Horana local council. He said that one more letter is missing for the Horana Regional Sabha to implement the matter. One member of the council asked for about 50 loads of garbage to be dumped on his land. But it could not be sent because many problems arose. Since he is also a member of parliament, there will be no problem. If possible, please provide some garbage. Then we can save some money. Pay attention to that too.

Mr. Mahesh Kotalawala, Member of the Regional Assembly - United National Party

Honorable Chairman,661Villagers have submitted a complaint to you against a company that blocks the road leading to Namaluwa Kumbur, which is in the village official's domain in Kotalawala, and divides the land into parcels. What steps did you take in that regard? The villagers are demanding that the road to the paddy field should not be closed, leaving about 10 feet and selling the land. I say that it is better for you to talk to these paddy owners and solve this problem.

Honorable Pradeshiya Sabha Member Mrs. Champa Jayangani Kannangara - United National Party

Honorable Chairman, there is a dangerous place near the culvert on the Kolamadiriya new road, which is difficult for vehicles to pass through.

Honorable Regional Councilor Mr. W.A. Priyantha Alwis - Sri Lanka Podujana Peramuna

Honorable Chairman, Aruggoda Hirana is a grant road to Colombo. I always requested you to cut the grass on that road. Now the grass has been cut by Hirana police. But because the road on both sides is broken, the carpet road is getting broken. Can't remove a vehicle, potholes are everywhere. This has not been resolved since 6-7 months. According to the current situation in the country, it is not possible to carpet the road once in a while. Therefore, if these existing roads are not protected, it will become a big problem. Therefore, I request you to maintain these roads instead of starting new works.

It should also be said that the first building on the fairgrounds is in a very dangerous situation. If it is not resolved now, the council will suffer a great loss. It is proposed to make a work plan to fix it immediately.

Hon'ble Regional Assembly Member Mr. Chaminda Dissanayake - Janata Vimukthi Peramuna

Honorable Chairman, he said that in 2012, he got the approval of the General Assembly to build a water tower on the Kidelpitiya Samargarden public land. You were the Vice President at that time when the approval of the General Assembly was obtained. There were several other MPs. On the other hand, as soon as the consent of the council is given to take the public land to build a water tower, the section of the Housing Development Authority's public land allotment act is violated. Didn't anyone talk then that we should give this public land to a water tower and reserve a small place somewhere else for those people.

Honorary Chairman Mr. H. A. H. Devendra Perera - Sri Lanka Podujana Peramuna

The biggest need of the people at that time was to get water for the people of that area. There was no other option for this. From Medagama to Senapura Kidelpitiya, the people of the area were facing a big problem without any way to get water. If the pressure of water coming from Bandaragama water tower is not enough, give water to that area. According to the demand of the people, the proposal to build this water tower under the Kalu Ganga National Water Supply Project was presented to us. At that time, all the former MPs unanimously agreed to it. The people's need for water was paramount at that time.

At that time, the public facility land was allocated to a water tower. Now the common facility area of the temple land has been divided into a separate form. It doesn't matter either. I have received a copy of your letter addressed to the Deputy Director of the Housing Development Authority. Ita Kanaka has mentioned that "Bandaragama Divisional Secretary also inspected the place and I further inform you that the necessary legal work to reserve a part of the cemetery is already being done." that I asked the Divisional Secretary whether she agreed to give a part of the cemetery. She said she did not agree. No agreement has been received for that. It has not been received from the people either. You said to hold a public discussion but it has not been held yet.

For that, there are more than three hundred people who expressed their interest and signed and gave signatures. These days I am busy so I could not hold that meeting. I talk to the officials and the priest of the temple and hold the meeting in the temple. One day I will inform.

Mr. Mahesh Kotalawala, Member of the Regional Assembly - United National Party

There was no opposition from the villagers when the water tower was built on the Samargadan land. Mr. Upul Indika, who was a member of parliament representing that division at that time, also agreed to that proposal. There was nothing wrong with that at that time. It was allowed because there was no problem.

Honorable Regional Assembly Member W.M. Ajith Seneviratne - Sri Lanka Podujana Peramuna

Honorable Chairman. The reason for the accidents on the roads is the problems on the roads. Some of them we can solve and some of them we cannot solve. I spoke on two occasions regarding the Pingwala road problem where you said that it has not been assigned to the council yet. butRDWhen they talk together, they say that they have been assigned. However, there is great danger there. I hope it will be fixed. You mentioned that you are preparing the roads in the divisions. We should identify the dangerous places on the roads and fix the broken places on those roads.

We built a shop for the self-employed. We did a program to sell the products of the villagers to them on two occasions. But it was not as successful as expected and the people are not interested and are waiting for the subsidy to earn some money. There was the cooperative on the other side, and it was necessary to maintain this so that the cooperative would not have a conflict. The operation of the cooperative was hampered because the cooperative was broken into twice by thieves. I suggested to the Divisional Secretary that we combine the cooperative and our concept and move this store forward. She agreed. Accordingly, the program of selling our products with the cooperative is going very successfully. Because it has been made safe, now the influence of thieves has decreased. If the wall at the back is built, the whole area will be well protected. Provide necessary facilities in that regard.

Currently, food safety and nutrition are strongly socialized. In the past, there was a food shortage, so people were encouraged to grow crops in their own gardens. But it has decreased by now. Nationally, we must take this up again or it will be difficult to find solutions to the food problem of the people. It is suggested that we implement some program as a congregation without limiting ourselves to the speech.

Honorable Pradeshiya Sabha Member Mrs. Champa Jayangani Kannangara - United National Party

Honorable Chairman, there is a plot of land on Okkanduwa road in Panape. It tells a story that builds up. It is walled up and now a gate has been put up and nothing can be seen. Night after night, soil is brought from tippers and the land is filled. Find out a little about it. The bridge on Okkanduwa Road has been

blown up. Therefore, it would be better to put two boards on both sides to restrict the passage of heavy vehicles.

Honorable Vice President Mr. Sarath R. Ranasinghe - Sri Lanka Podujana Peramuna

Honorable Chairman, Aluthgama village road carpet work has started under the lakh project. Now it is impossible to go on the road. As it is a road belonging to the local council, it is not good for the local council to have the road in that condition. We have maintained that road before. Now it has come to an impossible situation.RDCome out and go to the roadABChave left The carpet will not be available now the way this government is going. So I say let's put some tar over this and pave the way.

Honorary Chairman Mr. H. A. H. Devendra Perera - Sri Lanka Podujana Peramuna

In the discussion that day, we were advised to go to carpetABCHe said that he would give the opportunity to complete the work on several projects that had been stopped in the middle. In the division of the Vice President, the two roads namely Grammana Road and Vevita Yatiyana Road were named. Most of the work on those two roads will be completed. If not, we will try another option.

Honorable Vice President Mr. Sarath R. Ranasinghe - Sri Lanka Podujana Peramuna

And the other roads are also very dilapidated. The circular of the Ministry of Finance applies mainly to other major government institutions. The financial control of those government institutions is strict. A regional council like this earns revenue. I do not think that there will be any problem in using the money sought by the council for the maintenance of the area. I suggest that the money of the regional council should be used for the development activities of the jurisdiction.

The President has given instructions to relax the circulars. After relaxing those circulars, let's do the work we need and can do.

Mr. Mahesh Kotalawala, Member of the Regional Assembly - United National Party

Honorable Chairman, the President has issued circulars according to the situation in which this country has been appointed. Don't blame the President for that. Your government should be held accountable for bringing the country to this state. The chairman stopped the lunch given to the members of the council due to the problem of lack of money. You say to use the money of the council to build roads. We are against that.

Honorable Vice President Mr. Sarath R. Ranasinghe - Sri Lanka Podujana Peramuna

We are the representatives of the people elected by the people. We won the division. We should be accountable to the people of our constituencies. We have responsibility and accountability.

Honorable Regional Council Member Mr. Ruwan P. Perera - Sri Lanka Podujana Peramuna

MP Mahesh clearly said that he is against building roads with council funds. Record it clearly.

Mr. Mahesh Kotalawala, Member of the Regional Assembly - United National Party

At a time when this country is in a financial crisis, there is more work to be done in this country than building roads. That's what I'm saying.

Honorable Regional Assembly Member Mr. DJ Samith Janaka Fernando - Janata Vimukthi Peramuna

Honorable Chairman, MP Mahesh surprisingly agrees to cut costs. It is said that the circulars were issued because of financial problems, but the President has 14 advisers and 6 cameramen. If you take the entire staff, you can control Bandaragama, if you take the staff of the President. A party that could not get 2 lakh people's votes now needs to be inflated. They have no problem with cash vehicles. If something is done for the people of the village, money problems will come. The Chairman mentioned earlier that in the discussion with the Prime Minister, he asked to relax the circulars and allow the use of money. But the president's representative here says that he is against using that money. These stories are contradictory, aren't they?

Honorary Chairman Mr. H. A. H. Devendra Perera - Sri Lanka Podujana Peramuna

It is a personal opinion of Mr. Mahesh. There will be an opportunity to relax the circulars and work according to the council provisions. Let us act accordingly.

Honorable Pradeshiya Sabha Member Mrs. Deepani Kandaanarachchi - Sri Lanka Freedom Party

Honorable Chairman, until now we have built the roads very well. In the past, even the side roads were carpeted. But after doing all these things, there is a problem of no follow-up in this country. That is the cause of national crimes. In my area, the vehicles coming from Horana side and Kalutara side in Sariraja Mawatha use that side road and come to the main road. Both light vehicles and heavy vehicles go there. The road has now sunk due to heavy vehicles. The carpet level on that road is now gone. During the rainy season, the carpet gets waterlogged and rots. I also informed you about this over the phone. Stop the heavy vehicles on this road. If possible, put a sign on this road saying that heavy vehicles are prohibited.

Honorary Chairman Mr. H. A. H. Devendra Perera - Sri Lanka Podujana Peramuna

That road does not belong to the council. It is a road belonging to the Provincial Road Development Authority. I would advise them to check and fix it.

<u>Honorable Pradeshiya Sabha Member Mrs. Deepani Kandaanarachchi - Sri Lanka Freedom Party</u> You should force them to implement these decisions as soon as possible.

Honorary Chairman Mr. H. A. H. Devendra Perera - Sri Lanka Podujana Peramuna

Even though we say to stop the entry of heavy vehicles on the roads, we do not stop them by hitting such boards. They will go and examine it and see how the road will be useful for the people who travel on that road, and after investigating, they will decide whether heavy vehicles should be banned from traveling on that road or not. We can make a request. There is a special committee of the Provincial Road Development Authority that decides to stop the entry of heavy vehicles on that road. Let us make a request as a congregation.

Mr. M. Samanpa Dinendra - Sri Lanka Podujana Peramuna

Honorable Chairman, we need to talk about 3 things. The first thing is that the road leading to the Namalwa field was blocked and a land auction was being held. There was no road there, they are asking for a road. I request the chairman to direct this to the supervision of the work superintendent and take the necessary measures. The other thing is that MP Ruwan and MP Samith are talking about the Raigama Somananda Mawatha road. I was the member in charge of those divisions before going to divisional system. We built that road after spending nearly 70 lakhs. Now the road has become a drain and the drain has become a road. We request you to solve this road problem as soon as possible. Also Raigama East Ping Well is very old and a well used by many people. As per the request of MP Atigala and myself, we are requesting that Pinlanda be developed as soon as possible. Now with the current situation in this

country, when the people are unable to pay the water bill, because there are many people who use this well, we request that it be repaired as soon as possible.

Honorable Regional Councilor Mr. BG Dilan Rasika - Sri Lanka Podujana Peramuna

Honorable Chairman, I request that the maintenance of the road mentioned by Priyantha be done soon. Because of the potholes on that road, a child has fallen into a trap with his father. It is impossible to go that way. If two vehicles come, one vehicle has to be backed up. Only about 50 meters of this has to be built, it would be a great thing if it can be built quickly.

Honorable Regional Assembly Member Mr. DJ Samith Janaka Fernando - Janata Vimukthi Peramuna We have always talked in this House about the Wevita Lake. It looks like something is being done with the lake again.

Honorary Chairman Mr. H. A. H. Devendra Perera - Sri Lanka Podujana Peramuna

The coordination committee will be implemented by next week. In particular, when I made a request, there are several development projects that have been stopped in the middle and the damage that has been done to the lake should be talked about.

Honorable Regional Assembly Member Mr. DJ Samith Janaka Fernando - Janata Vimukthi Peramuna

Mr. Chairman. Although this Sabah did not talk about the laying of the Atulugama high-voltage power line system, it should be brought to your attention. So far, most of the business has been completed. According to the situation in Atulugama, such a high voltage power line system is not possible. The people of Atulugama have been planning this institution well in advance. In one house, the pillar is in the middle of the kitchen. Somehow, those people have been made to agree. Such a thing cannot be implemented in such an extremely densely populated area. At a legal workshop, MP Nafli presented this issue to the Legal Officer of the Local Government Department. Even she was surprised how a project like this could be done in such a place without taking permission. What a risk this is taking. Aren't there people in Atulugama? The regional secretary is also using her power to the fullest in this regard. What action did we take as a council? The electricity board doesn't care. We need to think with a philosophical mind regarding the people of Atulugama, there are children who are good at sports in Atulugama. It is never good to push those people into a narrow place. We should intervene if we can. I am intervening in this regard. A case has now been prepared to be filed in the Court of Appeal. The relevant persons have been referred to the Human Rights Commission. We are taking the best possible action in this regard. The lives of the people of Atulugama were sacrificed for one company. Institutions need such power supply. But they are put from unpopulated areas. When you do something like that, you have to take over the land and pay for it. Law officers know very well that this is wrong. In this regard, we as a congregation should oppose this as people in our jurisdiction.

Honorary Chairman Mr. H. A. H. Devendra Perera - Sri Lanka Podujana Peramuna

In this regard, the Divisional Secretariat formed a separate committee and started implementing the project. The local council has nothing to do with this. At the request of the people, I went to some places and checked what steps should be taken. The local council was not contacted during the implementation of the plan.

Mr. Gara Chairman, mentioning my name, it was mentioned that the way I behaved in the last assembly was wrong. When I go on a political journey, there are people who like and dislike and fear. All the former MPs saw what happened. As you said, with a respectful invitation, I was asked to withdraw the statement. In the process, we solved our problem. I became a senior member because of people who did politics honestly. When I leave here, all these MPs are the same to me. Also, even though the Siriraja Mawatha mentioned by MP Deepani is not our own road, it was cleaned twice with the machinery of the council. There is no permanent drain there. During the rainy season, there is a dip in the road due to standing water. People think that this road belongs to the council. Therefore, this should be done as soon as possible after informing the Provincial Road Development Authority.

Permission from the Honorable Chairman. The beloved mother of Mr. Asiri, Revenue Inspector of Bandaragama Regional Council, passed away recently. Permission from the Chairman. I would like to thank the chairman for preparing the Bandaragama market lane using premix. And there I saw some small things. After putting the premix, the grinding machine stops at 5 minutes. There is a technical error. Also, there is a small corner where you can buy premix. It takes a long time to get the premix. Consider those two things.

Also, as Rajitha MP said, Delgahawatta Temple Road has not been paved for a long time. Also, Haddagoda Samaranayake Road is requested to be completed soon. Due to the Atulugama high voltage power line system, not a single light is lit on the road leading from the house of Mr. Raja Samaranayake to Atulugama. It is requested to arrange it as soon as possible.

Also, it should be remembered that after 21 years, the Provincial Kabaddi champion, Bandaragama Pumakha Kalutara district team won. 7 Bandaragama players competed in the team. I helped the team as much as I could.

The Chairman of the Coordinating Committee does not make decisions for the number of officials. There is no point in having such a coordination committee. When the chairman takes a decision, there should be officers who can implement it. Therefore, I request you to draw your attention to it and spread awareness where necessary.
